

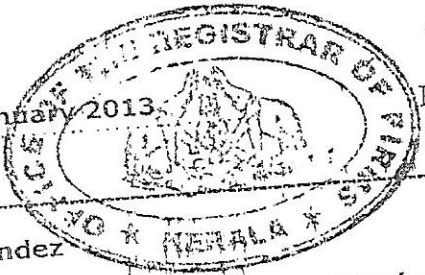

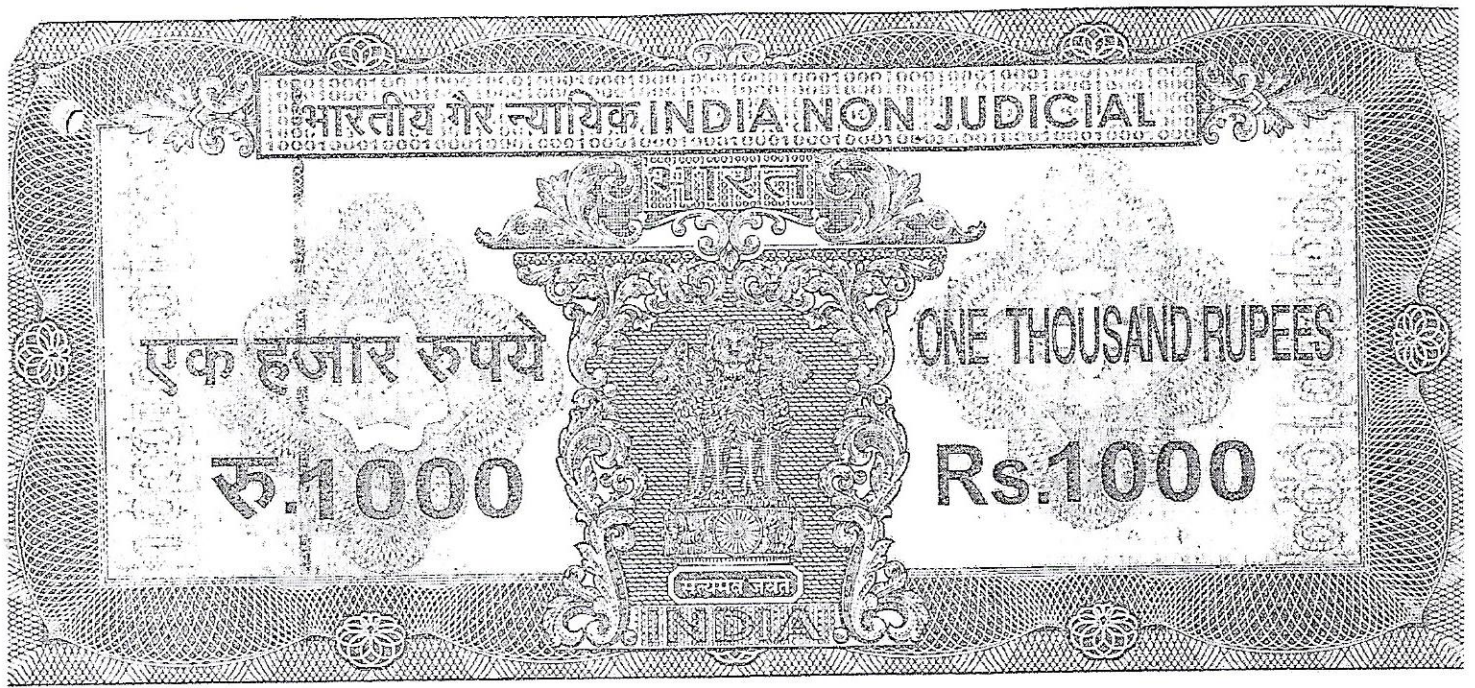

THIS DEED OF PARTNERSHIP

THIS DEED OF PARTNERSHIP is made on 13th day of December 2012 BETWEEN Mr. Johney Fernandez, aged 49, S/o Lawrence Fernandez, St. Jude Apartments, A3, Pangappara, Sreekariyam P.O. Pin-695017, Thiruvananthapuram District, Kerala State, India (hereinafter called First Party) AND Mr. Leejo Johney, aged 21, S/o Johney Fernandez, St. Jude Apartments, A3, Pangappara, Sreekariyam P.O., Pin- 695017, Thiruvananthapuram District, Kerala State (hereinafter called Second Party).

WHEREAS the above said parties have agreed to become partners with each other to carry the business specifically mentioned as follows:

1. Name of the Firm

CATALYST HOLIDAYS

2. Commencement

The partnership has commenced from 13th day of December 2012.

3. Place of Business

The principal place of business shall be at G2, Techno Mall, Near SBI Bank, Technopark, Kazhakuttam, Pin-695581 Thiruvananthapuram District, Kerala State, India. The firm may open branch branches at such other place/ places as the partners may agree upon.

4. Objects

The objective of the partnership shall be to carry on the business of Travel and Tourism Services, including arrangement of Tour Packages, Stay and Accommodation services and all allied services. The firm may also be engaged in any other business, which in the opinion of the partners can conveniently and profitably be carried on in addition to or in extension of the above said business.

5. Duration

The partnership shall be 'AT WILL'.

6. Capital

The capital of business shall be ₹ 1,00,000/- (Rupees One Lakh only) invested by the partners as under

(1) Johney Fernandez- 90,000/- (Rupees Ninety Thousand)

(2) Leejo Johny- 10,000/- (Rupees Ten Thousand)

The capital mentioned in this clause be varied from time to time by the partners by mutual consent.

7. Management

a. The 1st partner Johney Fernandez shall be the Managing Partner and shall be responsible for the management and the conduct of the business.

b. One or more account shall be opened with any banking financial institution which shall be opened and operated by the 1st party alone.

- c. All the amount required for the business in addition to the capital contributed by the partners shall be raised from bankers/ financial institutions/ individuals or by partners themselves on such terms and upon such security as may be agreed upon by the partners.
- d. None of the partners shall without the previous consent in writing of the other partner do any of the following acts or things.
- (i) Become bail, safety, surety or security for any person or corporation or to knowingly suffer anything, whereby the property of the partnership business shall be endangered, seized, attached or taken in execution.
 - (ii) Assign, mortgage or transfer his share or interest in the partnership to any other person or to introduce or attempt to introduce any other person to the business of the partnership.
 - (iii) To compromise or compound or accept on payment thereof any money in full release or discharge or debt due to partnership.
 - (iv) Withdraw any suit or proceedings filed on behalf of the firm.
 - (v) Admit any liability in any suit or proceeding against the firm.
- e. Each partner shall indemnify the firm for any loss or damage caused to it by his act of dishonesty or negligence in the conduct of the business of the partnership.

8. Book of Accounts

Proper books of accounts, records and registers etc. as usually maintained by a business of similar nature shall be maintained at the principal place of business.

9. Division of Profit/ Loss

The profit and loss of the firm shall be divided by the partners in the ratio 90:10.

10. Retirement Dissolution

- a. Any partner who is desirous of terminating his connection with the firm shall do so by serving notice in writing to the other partners one month prior to his retirement.

- b. As on the date of retirement or death, a profit and loss account shall be prepared and the balance credit/ debit shall be settled within one month from the date of retirement or term.

11. Minutes


The partners may maintain a minutes book in which shall be recorded all decisions they take in relation to the partnership business and each decision shall be valid and binding on the partners.

12. Miscellaneous

S. Sasi, Advocate who shall be the sole arbitrator whose decision shall be final and binding on all parties and their legal representatives. The parties may bring amendments to this deed of partnership if they so desires necessary in the form of resolution passed and duly incorporated in minutes.

13. General

In the other matters not expressly provided for therein above unless contracted otherwise by the partners, the provision of the Indian Partnership Act, 1932 shall be applicable to this partnership. 


