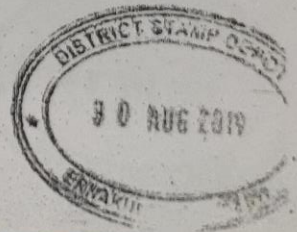

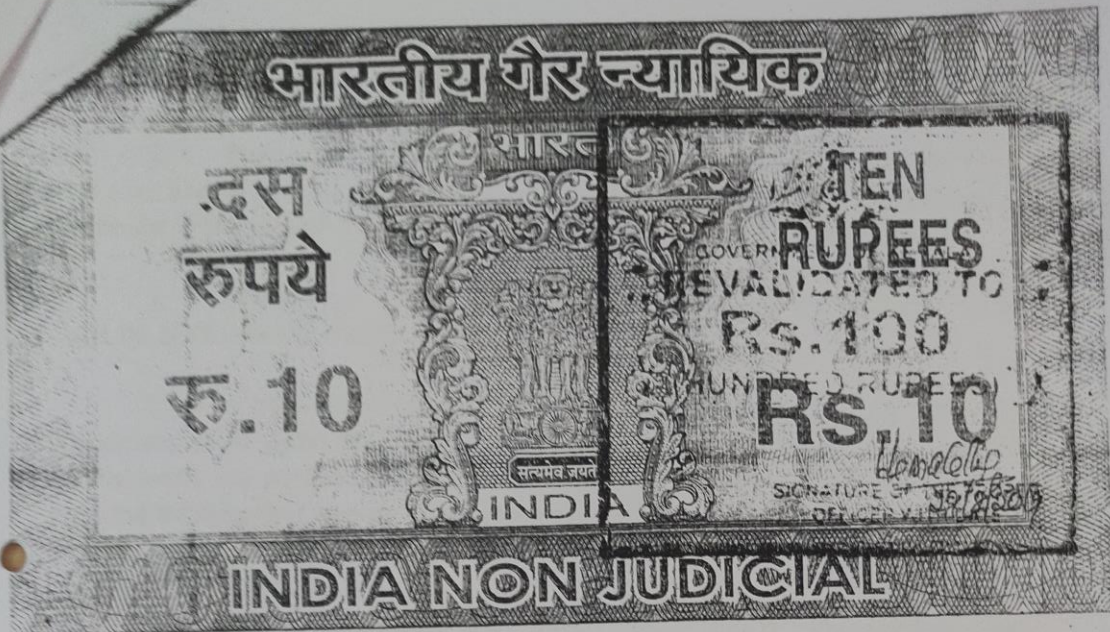

WHEREAS the lessor is the absolute owner of the Building bearing Cochin Corporation Door No.XXXV/99 (Old No. 49/2010), which is the ground floor of a two storied building named "Sarovaram", near Changampuzha Park, Edappally Raghavan Pilla Road, Edappally PO, Kochi - 682024. (1100 sq.ft)

AND WHEREAS, the lessee has requested the lessor to let out the said building for its business.

AND WHEREAS, the Lessor accepted the same and let out the building to the lessee with effect from [REDACTED] on the following terms and conditions.

NOW THIS DEED WITNESSETH AS FOLLOWS:-

1. The Lessee has agreed to pay a monthly rent of Rs.24,840/- (Rupees Twenty four thousand eight hundred & forty only) to the lessor on or before the 5th day of every succeeding English calendar month.

2. The Lessee has agreed that he will not commit default of payment of rent and in case he commits default he will pay interest for the defaulted amount at the rate of 12% per annum from the respective dates of default.

3. The period of lease is for 11 months from 1st August 2019 (01.08.2019 to 30.06.2020).

4. If the lessee wants to continue occupation of the demised premises even after the expiry of the period of 11 months fixed in the agreement, the period of lease can be extended by enhancing the rent by 8% on the existing rent and on such other terms and conditions mutually agreed by the parties at that time.

5. The lessee hereby undertakes to pay charges for electricity and water consumed by it directly to the authorities concerned and to hand over the receipts to the lessor.

6. The Lessee undertakes that during the tenure of the lease, he will use the premises only for its business purpose.

7. The lessee shall during the term of lease, keep and maintain the building with all its fitting and fixtures, a schedule of which is mentioned hereunder, in proper and good condition.

8. The lessee shall not make any alteration in the said building without the previous written consent of the lessor.

9. The lessee shall not use the building so as to destroy or reduce its value or utility in any manner.

10. The Lessee shall neither transfer his right nor sublet the building to anybody without previous written consent from the lessor.

11. The lessee shall permit the lessor, her servants and agents at all reasonable times to enter and inspect the building and carry out repairs, if necessary.

12. The Lessee shall surrender peaceful and vacant possession of the building on the expiry of the aforesaid period of 11 months in good condition as it is on this day.

13. The lessee undertakes to compensate the lessor in the event of any damage caused to the building due to the negligence of the lessee except normal wear and tear.

14. In the event of the lessee violating any of the provisions herein contained, the lessor has every right to terminate the lease with 15 days notice even before the expiry of the term of lease.

15. The lessee has paid an amount of Rs.1,20,000/- (Rupees One Lakh Twenty thousand only) to the lessor by way of Bank transfer as security deposit and the lessor has agreed to repay the deposit without interest at the time when the lessee surrenders vacant possession of the premises after deducting the arrears of rent if any committed by the lessee and the amount required for curing the damage, if any, caused to the building due to the negligent acts of the lessee.

16. If the lessor requires the building during the period fixed in the agreement, the lessee agree that he will surrender vacant possession of the building on getting one month's notice.

17. This agreement shall be subject to the jurisdiction of the courts of Ernakulam, alone.

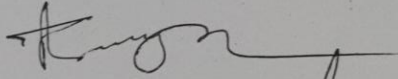

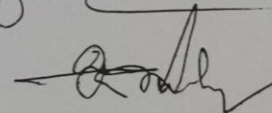

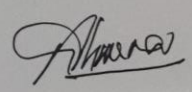
