

2. The monthly rent fixed for the both the shop rooms is Rs. 30,000/- (Rupees Thirty Thousand only) per month and the rent become payable within 5th day of every succeeding months and the rent shall be divided by the land lords equally or according to their mutual agreement.
3. The tenant agrees that the above said shop rooms hereby let out shall be used exclusively for his Travel service business only and will not sublet to anybody.
4. The tenant hereby agrees and undertakes that he will keep the above shop rooms and all its accessories and attachments in good condition without any damage and if any damage or loss is caused, the tenant will compensate the land lord adequately.
5. The tenant hereby unconditionally agrees to pay the monthly Electricity and water charges provided in the shop rooms to the concerned authorities as and when due without any default.
6. The tenant hereby agrees that he will not make any alteration or change the properties without prior written sanction of the land lords.
7. The tenant agrees that he will not induct any stranger into the premises without the writer sanction of the land lord.
8. The land lords agree that they shall pay the taxes for the both the shop rooms to the concerned authorities.
9. The tenant hereby agrees that on completion of the period of 11 months, he will surrender possession of the shop rooms to the land lords and thus the landlord will repay the security deposit to the tenant.


