<u>ORDER</u>

As per the Government Order read as 1st paper above, 'Tourism Working Capital Support Scheme' was approved for the entrepreneurs in the tourism industry to overcome the crisis due to the outbreak of COVID-19. The Director, Department of Tourism, as per the letter read as 2nd paper above requested Government to make some amendments to the Government Order regarding Tourism Working Capital Support Scheme considering the practical issues in implementation.

2) Government have examined the matter in detail and are pleased to make the following amendments to the Government Order read as 1st paper above subject to the condition that the number of beneficiaries shall not exceed the number decided before.

"The following shall also be included in Clause 2. Eligibility in the Guidelines:-

- l) Heritage Resorts classified by the Ministry of Tourism, Government of India (Copy of certificate to be enclosed).
- m) Accommodation units classified by the Ministry of Tourism, Government of India under the category Home Stay / Bed & Breakfast (Copy of certificate to be enclosed).
- n) Adventure Tour Operators accredited with the Ministry of Tourism, Government of India having registered office in Kerala (Copy of certificate to be enclosed).
- o) Those agencies engaged in adventure tour operation/adventure activity providers (with registered office in Kerala) who have a valid GST Registration (as adventure tour operator/adventure activity provider) and have filed GST returns for the last one year (Copy of GST registration to be enclosed).

Note:

Those establishments already applied for RENEWAL of statutory license from the authorities, and waiting for issuance of license in the wake of COVID-19, are also eligible for loan under the scheme, subject to production of acknowledgement of receipt of application from the authority concerned.

The clause 'GST Returns for the last two years' wherever mentioned in G.O.(Rt) No. 270/2020/TSM dated 14.08.2020 is substituted with 'GST Returns for the last one year (Annual/Quarterly for 4 quarters/Monthly for 12 months)'.

Section 1 (iii) (d) shall be substituted with the following

Tour operators/Travel Agents/Transport Operators having turnover of Rs.20-40 Lakhs/annum.

Section 2 (i) (c) shall be substituted with the following

Tour operators/Travel Agents/Transport Operators having turnover of Rs.40-75 Lakhs/annum.

Section 2 (ii) (d) shall be substituted with the following

Tour operators/Travel Agents/Transport Operators having turnover of Rs.75-150 Lakhs/annum.

Section 2 (iii) (d) shall be substituted with the following

Tour operators/Travel Agents/Transport Operators having turnover of Rs.150-250 Lakhs/annum.

Section 2 (iv) (c) shall be substituted with the following

Tour operators/Travel Agents/Transport Operators having turnover of Rs.250-400 Lakhs/annum.

Section 2 (v) (c) shall be substituted with the following

Tour operators/Travel Agents/Transport Operators having turnover of more than Rs.400 Lakhs/annum."

3) The Government Order read as 1st paper above stands modified to the above extent.
