#### 1. INTRODUCTION

The Expression of Interest is for Museum Consultants for Design and Execution of different types of Museums in the Muziris Heritage Project.

The Muziris Heritage Project is one of the most ambitious cultural conservation initiatives in India, spearheaded by the Government of Kerala to uncover, preserve, and celebrate the rich historical legacy of the ancient port city of Muziris. This region, stretching from North Paravur in Ernakulam district to Mathilakam in Thrissur district, was once a vibrant hub of maritime trade, cultural exchange, and religious coexistence. Historical evidence indicates that Muziris was a major trading center as early as the 1st century BCE, attracting merchants from Rome, Greece, the Middle East, China, and Africa, and serving as a melting pot of cultures, languages, and traditions.

The region's cultural and commercial history is both vast and unique. Muziris served not only as a gateway for spices, pearls, semi-precious stones, and textiles but also as a conduit for the exchange of ideas, art, and beliefs. Communities such as Jews, Arabs, Chinese, Romans, and later Europeans settled in or traded with this region, leaving behind distinct architectural, linguistic, and religious imprints. This complex and layered past is reflected in the diversity of monuments and sites that dot the Muziris landscape including ancient markets, synagogues, mosques, temples, churches, ports, and traditional settlements.

As part of the Muziris Heritage Project, many of these historic monuments, traditional structures, and heritage zones are being carefully conserved and adaptively reused as museums and interpretation centres. The objective is not only to restore and protect these structures using scientifically sound conservation practices but also to reimagine them as public spaces that educate, engage, and inspire. Buildings that once served as palaces, warehouses, places of worship, or residences are being thoughtfully transformed into narrative-driven museums, highlighting aspects such as Kerala's maritime history, multicultural society, traditional craftsmanship, and religious pluralism.

The project's conservation strategy is deeply rooted in community involvement, sustainable development, and cultural sensitivity. Local artisans, historians, and cultural practitioners are integral to the planning and storytelling processes. Additionally, the project envisions a long-term strategy to revitalize the region's economy through cultural tourism, creative industries, and heritage-linked enterprises. Planned initiatives such as the development of a Jewish Street experience, a floating food market, handicraft hubs, and waterfront tourism facilities are designed to foster both cultural preservation and economic growth, making heritage a living, evolving, and economically viable resource.

In this way, the Muziris Heritage Project stands not only as a model of heritage conservation but also as a visionary experiment in cultural regeneration, where history is preserved not just in stone, but in the living memory and active participation of communities.

#### 2. MISSION AND VISION OF MUZIRIS HERITAGE PROJECTS:

**Mission:** To preserve, interpret, and showcase the unique multicultural legacy of the ancient Muziris region through sustainable tourism, community involvement, and heritage education.

**Vision:** To establish Muziris as a globally significant heritage destination, where local communities thrive by participating in the conservation and promotion of their cultural assets, and visitors engage meaningfully with Kerala's layered historical narratives.

#### 3. PROJECT RATIONALE:

The empanelment process will help streamline consultant selection for project-

#### **5. PURPOSE OF EOI:**

The empaneled professionals may be engaged for tasks including museum space conceptualization, content development, curatorial planning, exhibit design and installation, conservation advisory, integration of digital technologies, community engagement, educational programming, and visitor experience enhancement. Assignments may relate to key upcoming projects such as the Cheraman Islamic Museum, Kottappuram Archaeology Museum, Kottappuram Fort Site Museum, and Kodungallur Bhagavathi Temple Museum etc., along with conceptual inputs for themed cultural initiatives like the Jewish Life Street, Floating Food Market, and experiential spaces in the Paravur Heritage Zone. The empanelment is intended to ensure high-quality, culturally authentic, and locally rooted museum experiences within the framework of sustainable heritage tourism.

#### 7. PROJECT DETAILS:

The proposed project under the Muziris Heritage Project aims to preserve both tangible and intangible heritage by developing museums, interpretive centers, and experiential tourism initiatives that are deeply rooted in community participation and sustainable development practices. Central to the initiative is the creation of dynamic museum spaces that not only house artifacts but also foster cultural storytelling, educational outreach, and immersive visitor experiences. #### 9. ELIGIBILITY CRITERIA

To ensure the selection of highly qualified and capable museum consultants for the Muziris Heritage Project, the criteria should align with the project's emphasis on historical authenticity, design innovation, community engagement, and sustainable development. Below are suitable criteria for selection of individuals or agencies through the EOI.

- Relevant experience in museum planning, curation, exhibition design, heritage interpretation, or visitor experience development.
- Ability to convert heritage structures into vibrant, engaging museum spaces that reflect the cultural, religious, and historical narratives of Muziris Heritage Projects.
- A solid track record of previous museum or art and heritage-related works/ exhibitions, especially involving adaptive reuse of heritage buildings or community-centric heritage storytelling.
- Should possess expertise in Curatorial Design & Storytelling.
- Must provide documentation or a portfolio of completed exhibition, museum/galleries or heritage-related projects.
- Should possess expertise in Exhibit Design & Fabrication.
- Ability to work in culturally diverse and historically sensitive environments.
- Should possess expertise in Educational and Community Engagement Programming.
- Must be a legally registered entity (e.g., Pvt. Ltd., LLP, Partnership Firm, Trust, Society, etc.) in India or abroad in the case of Firm.

- Should have at least minimum of 3 years of independent or institutional experience in museum-related projects for individual applicant.
- Should have a Curator/Museologist as full-time employee OR consortium member in the case of firm.
- If you have previously worked on heritage-related or museum projects, you must submit experience letters when requested by the office.
- Should have sufficient operational capacity and staffing to undertake multidisciplinary assignments for executing projects of different scale.
- Must demonstrate capacity to independently deliver museum-related outputs or collaborate with design/execution teams.
- Should not be blacklisted or barred from participating in government tenders/projects.

#### 10. RIGHT OF ADMISSION:

The Managing Director of Muziris Projects Limited reserves the right to accept or reject any application at his sole discretion.

#### 11. SELECTION PROCESS:

- EOIs will be evaluated based on experience, concept quality alignment with MPL goals.
- Eligible individuals or agencies, upon submission and evaluation of their qualifications, experience, and financial capacity, will be shortlisted by a designated committee.
- The selection of applicants will be carried out by a committee appointed by the Managing Director, based on the eligibility criteria and conditions outlined in this document, as well as any additional criteria deemed relevant by the committee or the Managing Director.

The process of empanelment will be based on the documentation provided along with the Expression of Interest. Applications of only those individuals/firms who fulfill minimum prescribed criteria of qualification/experience will be considered.
