Name of Work: Supply and Installation of Prefabricated Toilet Block at Canal House, Thiruvanchikkulam

1. Introduction

Muziris Projects Ltd. (MPL), functioning under the **Department of Tourism, Government of Kerala**, invites **sealed tenders** from qualified and experienced contractors for the **supply and installation of a prefabricated toilet block** at **Canal House, Thiruvanchikkulam**, within the Muziris Heritage Project Zone.

The **Muziris Heritage Project** is one of India's largest heritage conservation and tourism initiatives, implemented to rediscover and showcase the legacy of the ancient port city of Muziris—once a global maritime trade hub connecting Kerala to the rest of the world. The **Canal House**, situated at Thiruvanchikkulam, plays a significant role in narrating the story of Kerala's inland waterways and their role in the region's history and trade. The installation of a modern, eco-friendly **toilet block** at this site aims to improve visitor amenities and support sustainable tourism, while maintaining the sanctity and aesthetics of the heritage environment.

2. SCOPE OF WORK

The scope of work includes **supplying**, **installing**, **and commissioning one prefabricated portable single-unit toilet** at Canal House, Thiruvanchikkulam, complete with civil, plumbing, electrical, and sanitary fittings, as per the specifications given below.

SPECIFICATIONS:

• Type: Prefabricated portable toilet (Single Unit)

• **Dimensions:** 1500 mm × 1800 mm

Structure:

o Basement: Solid brick with plastering

o Wall, Floor & Roof Thickness: 90–100 mm, with sloped roof finished with natural tiles

o EPS Panel: 50 mm reinforced welded mesh (50×50 mm, dia. 2.5 mm)

Wall Finish: Concrete/Ferro cement/other durable materials (25 mm thickness)

• Electrical Works:

- o 20 mm ISI pipe with 1 sq.mm (branded)
- Switch box, modular switches, MCB system

• Plumbing Works:

o ISI-marked water and wastewater pipes

o EWC Closet: Branded

o Wash Basin: Branded

o CP fittings: Medium-grade brand

Overhead Water Tank: 500 L (pure water)

 Concrete/Ferro cement/other durable materials Septic Tank: 1000 L with outer pit and wastewater pit

Doors and Fittings:

Material: WPC (Frame & Shutter)

3. TIME FOR COMPLETION

The successful contractor shall complete the entire work within **30 (Thirty) days** from the date of issue of the **Work Order**.

4. TENDER FEE

Interested parties may apply by submitting the General application form along with fee and required documents to our office.

The application fee for participating in this tender is ₹1000 + GST. The tender fee is non-refundable.

5. ELIGIBILITY CRITERIA

- The bidder should have proven experience in similar prefabricated toilet installation works.
- The bidder must hold valid registration and GST certification.

6. VENDOR RESPONSIBILITIES & DELIVERABLES

- Provide all tools, tackles, scaffolding, safety gear and manpower required.
- Ensure debris removal and disposal in compliance with environmental norms.
- Submission of commissioning Certificates.
- Maintain minimum 12 months Defect Liability Period (DLP) post- handover.

- Rates quoted shall be inclusive of all materials, labour, transportation, and taxes.
- The contractor shall ensure that no damage occurs to heritage structures or the environment during execution.
- MPL reserves the right to accept or reject any or all tenders without assigning any reason.
- Any dispute shall be subject to the jurisdiction of courts in Thrissur, Kerala.
- The contractor shall follow all safety and environmental regulations during the execution of the work.
